May kindly see the property statement received online from Sri Mohd. Nasim, Addl. District & Sessions Judge, Hardoi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2018-2020 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2018-2020 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2018-2020 (2018-19 & 2019-20), the Gross income is Rs.39,58,572/-(Rs.35,70,056/- from Salary and Rs.3,88,516/- from LLM arrears) and total deductions/savings/investment against GIS, PPF, NPS, Car Loan repayments including down payment, Insurances and Income Tax is Rs.11,44,209/- and the balance of his savings bank account(s) is also increased by Rs.12,20,471/- in this financial year from previous year's balance, total of which is Rs.23,64,680/-. Thus, a sum of Rs.15,93,892/- was therefore available with him to meet out the household expenditure of his family consisting six members of the financial year 2018-2020 (2018-19 & 2019-20).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2016-2018 (2016-17 & 2017-18) online against Case Id: P00023242021 (Old Case Id: 4455) and the same has been processed before Hon'ble Mrs. Justice Manju Rani Chauhan, Administrative Judge, Hardoi Judgeship for Her Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-2020 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has firstly submitted movable and immovable property statements of the financial year 2018-2020 (2018-19 & 2019-20) vide online dated 10.12.2021. As such, there is delay in submitting the same for which the officer stated that (in his verbatim) "Very humbly submitted that due to some family disturbances and personal issues i could not submit my property Statements from the year of 2010 onwards. I seek unconditional apology and will take care in future", in the remark column.

May, therefore, if approved, property statements for the financial year 2018-2020 (2018-19 & 2019-20) of Sri Mohd. Nasim, Addl. District & Sessions Judge, Hardoi, be laid before Hon'ble Mrs. Justice Manju Rani Chauhan, Administrative Judge, Hardoi Judgeship for Her Lordship's kind perusal and orders?
