May kindly see the property statement online received from Sri Rakesh Kumar-V, Additional District & Sessions Judge, Kaushambi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2007-09 (2007-08 & 2008-09) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2007-09 (2007-08 & 2008-09) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2007-09 (2007-08 & 2008-09), his gross income from salary is Rs.5,47,799/- and total deductions/Savings/investments against Saving Bank Account Deposit, GPF, GIS, Income Tax, HRR and Insurances are Rs.2,25,421/-. The balance of Rs.23,454/- has increased from his saving bank A/c's against the balance of the previous year Thus a sum of Rs.3,22,378/- was therefore available with him to meet out the household expenditure of his family consisting three members in the financial years 2007-09 (2007-08 & 2008-09).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2005-07 (2005-06 & 2006-07) online against case id:P00039602021 (old case id-6108) and same has been processed before Hon'ble Mr. Justice Vikas Budhwar, Administrative Judge, Kaushambi Judgeship for His Lordship's kind perusal and orders

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2007-09 (2007-08 & 2008-09) in its next financial year i.e., 2009-10 upto March 2010. He has submitted movable and immovable property statements for the financial years 2007-09 (2007-08 & 2008-09) vide online dated 13.12.2021. As such, there is delay submitting the same. In this regard, officer verbatim: "..... I have been engaged in the treatment of my wife and son from the year 2009 to 2019 and from the year 2019 to 2021 respectively. During the treatment any how my wife's life was saved and son's leg was operated upon. The undersigned was mentally disturbed during the treatment. Due to above reasons, I was able to submit my property statement in the year 2021 after my wife and son became healthy. I apologize for the inconvenience caused to your goodself due to above reasons. The undersigned accepts his mistake and apologizes for not being able to submit the property statement in time. Inconvenience is highly regretted.

May, therefore, if approved, property statements for the financial years 2007-09 (2007-08 & 2008-09) of Sri Rakesh Kumar-V, Additional District & Sessions Judge, Kaushambi be laid before Hon'ble Mr. Justice Vikas Budhwar, Administrative Judge, Kaushambi Judgeship for His Lordship's kind perusal and orders?
