May kindly see the property statements online received from Sri Inder Preet Singh Josh, Presiding Officer, Commercial Court, Gautambuddha Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2017-18 & 2018-19 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2017-18 & 2018-19, Total income is Rs.59,34,653/- (total Gross salary is Rs.51,28,776/- and income from interests of FDR & SB a/cs of Rs.8,05,877/-) and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, PPF, Insurance policy, donation and the balance of his savings bank account(s) is enhanced for Rs.1,42,777/- this financial year from previous year's balance, total of which is Rs.19,94,575/-. Thus, a sum of Rs.39,40,078/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

It is pertinent to mention here that FDR of Rs.80,00,000/- has been matured and made again FDR of Rs.82,00,000/-. His wife is an advocate having annual income of Rs.22,00,000/- and Rs.12,88,247/- in the financial years 2017-18 & 2018-19 respectively.

In this connection, it is submitted that officer has submitted his property statement upto the financial year 2016-17, which had already been seen by Hon'ble Mr. Justice Pankaj Bhaita, the then Administrative Judge, Gautambuddha Nagar, placed in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements for the financial years 2017-18 & 2018-19 firstly vide online dated 10.12.2021. As such, there is delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2017-18 & 2018-19 of Sri Inder Preet Singh Josh, Presiding Officer, Commercial Court, Gautambuddha Nagar be laid before Hon'ble Mr. Justice Pankaj Bhaita, Administrative Judge, Gautambuddha Nagar for His Lordship's kind perusal and orders?
