May kindly see the property statement online received from Sri Pradeep Kumar Jayant, Special Judge (U.P. Dacoity.A.A.), Hamirpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2014-16 (2014-15 & 2015-16) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2014-16 (2014-15 & 2015-16) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2014-16 (2014-15 & 2015-16), Gross income from salary and other sources is Rs.20,78,184/- (income from salary including allowances Rs.20,40,204/-, income from Income Tax Refund Rs.17,980/- and income from LIC Rs.20,000/-) and total deductions/savings/ investment against GPF, GIS, Income Tax, PPF, Insurance policy, repayment of home & car loan and the balance of his savings bank account(s) is also increased by Rs.90,958/- in this financial year from previous year's balance, total of which is Rs.8,59,638/-. Thus, a sum of Rs.12,18,546/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the both of the financial year.

It is pertinent to mention here that Officer's wife Smt. Vidyawati Jayant, Income from Rent/Teaching, about Rs.1,50,000/-P.A.

In this connection, it is submitted that the Officer has already submitted his property statements upto the financial year 2013-14 offline and same has been Seen by Hon'ble Mr. Justice Tarun Agarwala, the then Administrative Judge, Kanpur Nagar in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2014-16 (2014-15 & 2015-16) in its next financial year i.e., 2016-17 upto March 2017. He has submitted movable and immovable property statements of the financial year 2014-16 (2014-15 & 2015-16) vide online dated 16.12.2021. As such, there is delay in submitting the same. In this regard, officer has not given any reason for delay submission.

May, therefore, if approved, property statements for the financial years 2014-16 (2014-15 & 2015-16) of Sri Pradeep Kumar Jayant, Special Judge (U.P. Dacoity.A.A.), Hamirpur be laid before Hon'ble Mr. Justice Syed Aftab Husain Rizvi, Administrative Judge, Hamirpur for His Lordship's kind perusal and orders?
