May kindly see the property statement online received from Sri. Vineet Kumar Yadav, Additional Civil Judge (Senior Division)/ACMM., Kanpur Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2018-20 (2018-19 & 2019-20), Gross income from salary Rs.20,70,777/- and total deductions/savings/ investment against NPS, GIS, Income Tax, PPF, LIC policy and the balance of his saving bank accounts is neither increased nor decreased this financial year from previous year's balance, total of which is Rs.4,47,473/-. Thus, a sum of Rs.16,23,304/- was therefore available with him to meet out the household expenditure of his family consisting of two members in the both of the financial year.

In this connection, it is submitted that the Officer has already submitted his property statements at the time of joining the U.P. Judicial Service online same has been processed before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Kanpur nagar on old case Id no-6178.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-20 (2018-19 & 2019-20) vide online dated 17.12.2021. As such, there is delay in submitting the same. In this regard, officer has stated that due to some inadvertence property statement could not be submitted on time. Officer humbly apologises for the delay in submitting statement in due time.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri. Vineet Kumar Yadav, Additional Civil Judge (Senior Division)/ACMM., Kanpur Nagar be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Kanpur Nagar for His Lordship's kind perusal and orders?
