May kindly see the property statement online received from Sri Perwaiz Ahmad, Additional District & Sessions Judge (POCSO), Kanpur Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2019-21(2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21(2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2019-21(2019-20 & 2020-21), Gross income is Rs.45,32,202/- (income from salary Rs. 40,82,084/- & income from bank interest Rs. 4,78,038/-) and total deductions/ repayment/ savings/ investment against GIS, Income Tax, GPF, PPF, LIC, total of which is Rs.22,32,589/-. Thus, a sum of Rs.22,99,613/- was available with him to meet out the household expenditure of his family consisting of five members in both of the financial years and the balance of his savings bank account(s) is decreased by Rs.3,49,685/- this financial year from previous year's balance.

In this connection, it is submitted that the Officer has already submitted his property statements of the financial year 2017-2019 offline and same has been seen by Hon'ble Ms. Justice Naheed Ara Moonis, the then Administrative Judge, Farrukhabad Judgeship in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21(2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial years 2019-21(2019-20 & 2020-21) vide online dated 14.12.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2019-21(2019-20 & 2020-21) of Sri Perwaiz Ahmad, Additional District & Sessions Judge (POCSO), Kanpur Nagar be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Kanpur Nagar for His Lordship's kind perusal and orders?
