

## **Registrar(J)(Budget)**

May kindly see the property statements online received from Sri Inder Preet Singh Josh, Presiding Officer, Commercial Court, Gautambuddha Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2019-20 & 2020-21 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-20 & 2020-21 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2019-20 & 2020-21, Total income is Rs.71,10,454/- (total Gross salary is Rs.59,97,756/- and income from interests of FDR & SB a/cs of Rs.11,12,698/-) and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, PPF, Insurance policies, donation, Gold bond and the balance of his savings bank account(s) is enhanced for Rs.35,52,653/- this financial year from previous year's balance, total of which is Rs.62,21,831/-. Thus, a sum of Rs.8,88,623/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

It is pertinent to mention here that FDR of Rs.72,00,000/- (mentioned in attachment "**Property statement 2019-20**" & "**Property statement 20-21**") has been matured and made again FDR of Rs.61,00,000/-. His divorce proceedings are pending with spouse.

In this connection, it is submitted that officer has submitted his property statement upto the financial year 2016-17, which has already been seen by Hon'ble Mr. Justice Pankaj Bhatia, the then Administrative Judge, Gautambuddha Nagar, placed in the misc. file of the officer and property statement of the financial years 2017-18 & 2018-19 has been processed on e-service ID P00040332021.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-20 & 2020-21 in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements for the financial years 2019-20 & 2020-21 firstly vide online dated 10.12.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2019-20 & 2020-21 of Sri Inder Preet Singh Josh, Presiding Officer, Commercial Court, Gautambuddha Nagar be laid before Hon'ble Mr. Justice Pankaj Bhatia, Administrative Judge, Gautambuddha Nagar for His Lordship's kind perusal and orders?
