May kindly see the property statement received online from Sri Rakesh Kumar-V, Addl. District & Sessions Judge, Kaushambi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2015-2017 (2015-16 & 2016-17) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2015-2017 (2015-16 & 2016-17) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2015-2017 (2015-16 & 2016-17), the Gross income from salary is Rs.28,95,959/- and total deductions/savings/investment against GPF, GIS and Income Tax are Rs.4,81,057/- and the balance of his savings bank account(s) is also increased by Rs.13,95,321/- in this financial year from previous year's balance, total of which is Rs.18,76,378/-. Thus, a sum of Rs.10,19,581/- was therefore available with him to meet out the household expenditure of his family consisting three members of the financial year 2015-2017 (2015-16 & 2016-17).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2013-2015 (2013-14 & 2014-15) online against Case Id : P00040402021 (Old Case Id : 6189) and the same has been processed before Hon'ble Mr. Justice Vikas Budhwar, Administrative Judge, Kaushambi Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2015-2017 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto March 2018. He has firstly submitted movable and immovable property statements of the financial year 2015-2017 (2015-16 & 2016-17) vide online dated 13.12.2021. As such, there is delay in submitting the same for which the officer has stated in his online reply dated 03.08.2023, that (in his verbatim) *"I have been engaged in the treatment of my wife and son from the year 2009 to 2019 and from the year 2019 to 2021 respectively. During the treatment any how my wife's life was saved and son's leg was operated upon. The undersigned was disturbed by this reason during the treatment. Due to above reasons, I was able to submit my property statement in the year 2021 after my wife and son became healthy. I apologize for the inconvenience caused to your goodself due to above reasons. The undersigned accepts his mistake and apologizes for not being able to submit the property statement in time. Inconvenience is highly regretted."*

May, therefore, if approved, property statements for the financial year 2015-2017 (2015-16 & 2016-17) of Sri Rakesh Kumar-V, Addl. District & Sessions Judge, Kaushambi, be laid before Hon'ble Mr. Justice Vikas Budhwar, Administrative Judge, Kaushambi Judgeship for His Lordship's kind perusal and orders?
