May kindly see the online property statements received from Smt. Alka Pandey, Judge Small Causes Court, Bareilly regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2017-18 & 2018-19 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial year 2017-18 & 2018-19, total Gross income is Rs.17,90,413/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, Car loan and the balance of her savings bank account(s) has also been enhanced for Rs.71,039/- this financial year from previous year's balance, total of which is Rs.6,11,697/-. Thus, a sum of Rs.11,78,716/- was therefore available with her to meet out the household expenditure of her family consisting three members in both the financial years.

It is pertinent to mention here that her husband is S.D.M. having annual income of Rs.6,84,160/- and Rs.7,55,800/- in the financial years 2017-18 & 2018-19 respectively.

In this connection, it is submitted that the officer has already submitted her property statements at the time of entering into judicial service, and of the financial years 2013-14 & 2014-15 offline, on which a detailed offline note has been laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders, placed in the misc. file of the officer. And officer has also submitted online property statements of the financial years 2015-17, on which a separate online note has been laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders on eService portal P00040172021.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement of the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. She has submitted movable and immovable property statements of the financial years 2017-18 & 2018-19 firstly vide online dated 14.12.2021. As such, there is delay in submitting the same from the part of the office for which she has stated that "*she sincerely apologises for not submitting her property statement in due course of time and thereby, she is submitting her property statement forthwith. She humbly requests to consider her apology and condone the inadvertent delay in filing her property statement*", mentioned in her reply dated 13.02.2024.

May, therefore, if approved, property statements of the financial year 2017-18 & 2018-19 of Smt. Alka Pandey, Judge Small Causes Court, Bareilly be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders?
