May kindly see the property statement online received from Sri Amit Malaviya, Special Judge (SC/ST, Pev. of Atroci Act), Ramabai Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2014-16 (2014-15 & 2015-16) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2014-16 (2014-15 & 2015-16) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

In the financial years 2014-16 (2014-15 & 2015-16), Total income from salary & arrears is Rs.21,73,302/- and total deductions/repayment/ savings/ investment against NPS, GIS, Insurances, Income Tax and PPF, total of which is Rs.6,05,158/-. Thus, a sum of Rs.15,68,144/- was therefore available with him to meet out the household expenditure of his family consisting of three members for both the financial years 2014-16 (2014-15 & 2015-16). And the balance of his savings bank account(s) is reduced for Rs.63,100/- this financial year from previous year's balance.

It is pertinent to mention here that Smt. Divya Malaviya (Wife) Practicing as Advocate, Gross Total Income Rs.84000/-for F.Y. 2014-15 and Rs.147300/- for F.Y. 2015-16.

In this connection, it is submitted that the Officer has already submitted his property statements upto the financial year 2012-14 which has already been processed before Hon'ble Mr. Justice Subhash Vidyarthi, Administrative Judge, Ramabai Nagar on old case Id no-6241.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2014-16 (2014-15 & 2015-16) in its next financial year i.e., 2016-17 upto March 2017. He has submitted movable and immovable property statements of the financial years 2014-16 (2014-15 & 2015-16) vide online dated 12.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, he has stated that due to busy in work, he could not submit the same on time, for which he apologizes. He assured that he will submit the same on time in future without any mistake.

May, therefore, if approved, property statements for the financial years 2014-16 (2014-15 & 2015-16) of Sri Amit Malaviya, Special Judge (SC/ST, Pev. of Atroci Act), Ramabai Nagar be laid before Hon'ble Mr. Justice Subhash Vidyarthi, Administrative Judge, Ramabai Nagar for His Lordship's kind perusal and orders?
