May kindly see the online property statements received from Smt. Alka Pandey, Judge Small Causes Court, Bareilly regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2019-20 & 2020-21 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-20 & 2020-21 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial year 2019-20 & 2020-21, total Gross income is Rs.26,55,538/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, Home loan, PPF, Mutual fund and the balance of her savings bank account(s) has also been enhanced for Rs.2,35,622/- this financial year from previous year's balance, total of which is Rs.11,46,128/-. Thus, a sum of Rs.15,09,410/- was therefore available with her to meet out the household expenditure of her family consisting three members in both the financial years.

It is pertinent to mention here that her husband is S.D.M. having annual income of Rs.9,26,190/- and Rs.9,41,508/- in the financial years 2019-20 & 2020-21 respectively.

In this connection, it is submitted that the officer has already submitted her property statements at the time of entering into judicial service and of the financial years 2013-14 & 2014-15 offline, on which a detailed offline note has been laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders, placed in the misc. file of the officer. And officer has also submitted online property statements of the financial years 2015-17 & 2017-19, on which separate online notes has been laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders on eService portal P00040172021 & P00040702021 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement of the financial years 2019-20 & 2020-21 in its next financial year i.e., 2021-22 upto March 2022. She has submitted movable and immovable property statements of the financial years 2019-20 & 2020-21 vide online dated 14.12.2021. As such, there is no delay in submitting the same.
