May kindly see the property statement received online from Sushri Kisa Zaheer, Judicial Magistrate, Lucknow, regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2018-2020 (2018-19 & 2019-20) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2018-2020 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial year 2018-2020 (2018-19 & 2019-20), the Gross income from salary is Rs.15,92,388/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Fixed deposit and Income Tax are Rs.3,28,005/- and the balance of her savings bank account is also increased by Rs.72,398/- in this financial year from previous year's balance, total of which is Rs.4,00,403/-. Thus, a sum of Rs.11,91,985/- was therefore available with herself in the financial year 2018-2020 (2018-19 & 2019-20).

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements held at the time of Joining into U.P. Judicial Service, online against Case Id: P00034332021 (old case id: 5578) and the same has been processed before Hon'ble Mr. Justice Rajan Roy, Administrative Judge, Lucknow for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2018-2020 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She has firstly submitted movable and immovable property statements of the financial year 2018-2020 (2018-19 & 2019-20) vide online dated 11.12.2021. As such, there is delay in submitting the same for which the officer has stated in the remarks column, that (in her verbatim) "I have joined judicial services in 2018. I have completed graduation in 2015 and thereafter started preparing for judicial services. The details submitted are from 18 June 2018(date of joining) to 31th March 2020. The delay has been caused due to difficulty in procuring details required. The undersigned humbly seeks unconditional apology for inadvertent delay. In future the undersigned will ensure timely submission of property statement. In anticipation of grace."

May, therefore, if approved, property statements for the financial year 2018-2020 (2018-19 & 2019-20) of Sushri Kisa Zaheer, Judicial Magistrate, Lucknow, be laid before Hon'ble Mr. Justice Rajan Roy, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
