May kindly see the property statement online received from Smt. Bhavya Tiwari, Civil Judge (Senior Division), Ayodhya regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2019-21(2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below-

In the financial years 2019-21(2019-20 & 2020-21), total gross income from salary & arrears is Rs.32,06,306/- and total deductions/ repayment/ savings/ investment against GIS, Income Tax, NPS, loans, LIC policies, PPF a/c , total of which is Rs.12,17,433/-. Thus, a sum of Rs.19,88,873/- was therefore available with her to meet out the household expenditure of her family consisting three members in both the financial years.and the balance of her savings bank account(s) is reduced for Rs.1,87,913/- this financial year from previous year's balance

It is pertinent to mention here that her husband is working as Review Officer in UP Civil Secretariat, Lucknow, in the F.Y. 2019-21 posted in Excise Department of UP having monthly income of Rs.56,900/-.

In this connection, it is submitted that officer has already submitted her property statement upto financial year 2018-19 which had already been Seen by Hon'ble Mr. Justice Mahesh Chandra Tripathi, the then Administrative Judge, Lucknow, in the old case id no. 5679.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2019-21(2019-20 & 2020-21) its next financial year i.e., 2021-22 upto March 2022. She has submitted movable and immovable property statements for the financial year 2019-21(2019-20 & 2020-21) vide online dated 11.12.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2019-21(2019-20 & 2020-21) of Smt. Bhavya Tiwari, Civil Judge (Senior Division), Ayodhya be laid before Hon'ble Mr. Justice Manish Mathur, Administrative Judge, Faizabad (Ayodhya) Judgeship for His Lordship's kind perusal and orders?
