May kindly see the property statement submitted online received from Sri Pradeep Kumar Singh-I, Additional District & Sessions Judge, Agra regarding submission of statements of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2017-19 (2017-18 & 2018-19), Total income from salary including arrears is Rs.30,18,688/- and total deductions/savings/investments against CPF/NPS, GIS, Income Tax, PPF, Insurances, repayment of housing loan and the balance of his savings bank account(s) is also enhanced for Rs.2,08,488/- this financial year from previous year's balance, total of which is Rs.15,32,928/-. Thus a sum of Rs.14,85,760/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years.

It is pertinent to mention here that wife of the officer Smt Shashi Bala Verma is a Govt. Teacher, having annual income 4 lacs.

In this connection, it is submitted that the officer has already submitted his property statements for the financial year 2015-17, which has already been processed online before Hon'ble Mr. Justice Suneet Kumar, Administrative Judge, Agra Judgeship on old case ID no-6368.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2017-19 (2017-18 & 2018-19) in its next financial year i.e. 2019-20 upto 31st March 2020. He has submitted movable and immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) vide his application dated 13.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, officer stated that due to lack of complete information, some family problems, busyness and corona pandemic, he could not sumbit the same within stipulated time. For which, he apologizes and ensured that in future he would submit the same within time.

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Sri Pradeep Kumar Singh-I, Additional District & Sessions Judge, Agra be laid before Hon'ble Mr. Justice Suneet Kumar, Administrative Judge, Agra Judgeship for His Lordship's kind perusal and orders?
