In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2017-19 (2017-18 & 2018-19), Total income from salary Rs.26,23,660/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, CPF, Income Tax, Insurance policy, NSC, PPF, SIP, repayment of home & car loan and the balance of his savings bank account(s) is enhanced for Rs.6,29,383/- this financial year from previous year's balance, total of which is Rs.23,74,282/-. Thus, a sum of Rs.2,49,378/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both the financial years.

It is pertinent to mention here that his wife Smt. Vineeta Singh is ACJM, Farrukhabad and her annual income for the F.Y. 2017-18 Rs.8,54,247/- and for the F.Y. 2018-19 Rs.15,44,751/-.

In this connection, it is submitted that the officer has submitted his property statement of the F.Y. 2015-17, which has been processed before Hon'ble Mr. Justice Chandra Kumar Rai, Administrative Judge, Sonbhadra on eService ID no. 6394.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial years 2017-19 (2017-18 & 2018-19) firstly vide online dated 12.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has not given any reason for delay.
