May kindly see the property statement online received from Sri Abhishek Upadhyaya, Additional District & Sessions Judge, Meerut regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2019-21 (2019-20 & 2020-21), his gross income from salary and other sources are Rs.59,69,702/- (Rs.38,46,802/- from salary and Rs.21,22,900/- from Wing Colonizer Ltd. Purchase option) and total deductions/Savings/investments against Deposits in Saving Bank Account, NPS, GIS, Income Tax, Insurance, PPF, Shares and FD is Rs.38,42,527/-. The balance of Rs.4,08,990/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.21,27,175/- was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2019-21 (2019-20 & 2020-21).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2013-14 to 2018-19 in offline mode, which already had been seen by Hon'ble Mr. Justice Vivek Kumar Birla, the then Administrative Judge, Kanpur Nagar in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) vide online dated 13.12.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sri Abhishek Upadhyaya, Additional District & Sessions Judge, Meerut be laid before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Meerut Judgeship for His Lordship's kind perusal and orders?
