May kindly see the property statement received online from Sri Shushil Kumar Verma, A.D.J. (FTC), Chitrakoot, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2015-2017 (2015-16 & 2016-17) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2015-2017 (2015-16 & 2016-17) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2015-2017 (2015-16 & 2016-17), the Gross income from salary is Rs.18,57,993/- and total deductions/savings/investment against GIS, CPF, PPF, FD, Car Loan repayments, Insurances and Income Tax is Rs.9,35,301/-. Thus, a sum of Rs.9,22,692/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2015-2017 (2015-16 & 2016-17) and the balance of his savings bank account(s) is also decreased by Rs.44184/- in this financial year from previous year's balance.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2014-2015 offline and the same has been seen by Hon'ble Mr. Justice A. N. Mittal, the then Administrative Judge, Bhadohi Judgeship, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2015-2017 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto March 2018. He has submitted movable and immovable property statements of the financial year 2015-2017 (2015-16 & 2016-17) vide online dated 14.12.2021. As such, there is delay in submitting aforesaid property statements from the part of the officer. In this regard, the officer stated that (in his verbatim) "due to busy in work and missing of some bank documents and mother health problem I could not submit the property statement in time. So I regret for this and seek apology to Hon'ble Court. Please accept my apology for delay", in the remark column.

May, therefore, if approved, property statements for the financial year 2015-2017 (2015-16 & 2016-17) of Sri Shushil Kumar Verma, A.D.J. (FTC), Chitrakoot, be laid before Hon'ble Mr. Justice Vikram D Chauhan, Administrative Judge, Chitrakoot Judgeship for His Lordship's kind perusal and orders?
