May kindly see the property statement received online from Sri Pushpender Singh, Additional District & Sessions Judge, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

In the financial years 2018-20 (2018-19 & 2019-20), Total income is Rs.63,76,901/- (income from salary Rs.45,88,517/-, income from sale of car Rs.1,50,000/-, income from sale of land/property Rs.15,00,000/- and income from mutual fund redemption Rs.1,38,384/-) and total deductions/ savings/ investment against NPS, GIS, Income Tax, PPF, Sukanya samridhi yojna, Fixed deposit, Mediclaim & Health insurance, and the balance of his savings bank account is also enhanced for Rs.14,37,311/- in this financial year from previous year's balance, total of which is Rs.36,32,862/-. Thus, a sum of Rs.27,44,039/- was therefore available with him to meet out the household expenditure of his family consisting of three members for both the financial years.

It is pertinent to mention here that his wife Dr. Suruchi Singh is working as Legal consultant/practicing Advocate and her annual income is Rs.2,50,000/- & Rs.2,70,000/- for the financial years 2018-19 and 2019-20, respectively.

In this connection, it is submitted that the officer has already submitted his property statements upto the financial years 2016-17 & 2017-18 and the same has also been seen offline by Hon'ble the Chief Justice, in the mpisc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20(2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20(2018-19 & 2019-20) vide online dated 12.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, officer has attached a letter for delay condonation request, wherein he has stated that "he was involved in the computerisation/video conference coordination in the District Courts of U.P. during covid pandemic and also assisted Hon'ble Court in working through virtual mode during above period. Therefore, inadvertently, he could not file the property statement timely and he sincerely apologised for the delay and requested for sympathetic consideration."

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Pushpender Singh, Additional District & Sessions Judge, Lucknow, be laid before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow Judgship for His Lordship's kind perusal and orders?
