May kindly see the property statement received online from Sri Shushil Kumar Verma, A.D.J. (FTC), Chitrakoot, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2019-2021 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection it is submitted that earlier, after perusal of the above property statement, through online objection dated 22.11.2023, the officer was asked how was the household expenditure maintained in the financial years 2019-20 & 2020-21 with meagre amount of Rs.1,77,389/-. The officer has stated in his online reply dated 29.11.2023, that (in his verbatim):

"With regard to the objection raised in my property statement with regard to financial year 2019-2020 & 2020-2021, it is most humbly stated that the House Loan repayment amount Rs. 6,63,600/- was inadvertently noted In my property statement due to typing mistake. The actual Housing loan amount deposited in the period 01 April 2019 to December 2019 is Rs. 1,17,666.00 whereas from 01 January 2020 to 31 March 2021 Rs. 4,14,750.00. In this way, the total loan amount deposited during financial year 2019-2020 and 2020-2021 Is Rs. 5,32,416.00 and not Rs. 6,63,600/- as has been mentioned in my property statement. In this way I was left with Rs. 1,31,184- more rupees to maintain my household expenses.

I have to add further that financial year 2020 — 2021 was largely mired with Covid 19 Pandemic with lock down on several occasions. This whole financial year witnessed huge restrictions in the lifestyle of an individual and the whole family had to restrict within the house. Even the access to any place outside the house was widely restricted and schools were closed whereas markets or other institutions were rarely accessible. Due to all these restrictions and hardships during pandemic period, the expenditures had fallen down steeply upto not more than 7000/- per month and thus, I was able to maintain my household expences during these periods."

In this connection, it is further submitted that as per the statement of movable and immovable properties for the financial year 2019-2021 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2019-2021 (2019-20 & 2020-21), the Gross income from salary is Rs.31,07,507/- and total deductions/savings/investment against GIS, CPF, PPF, House Loan repayments, Insurances, and Income Tax is Rs.20,18,592/- and the balance of his savings bank account(s) is also increased by Rs.7,80,342/- in this financial year from previous year's balance, total of which is Rs.27,98,934/-. Thus, a sum of Rs.3,08,573/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2019-2021 (2019-20 & 2020-21).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2017-2019 (2017-18 & 2018-19) online against Case Id: P00043162021 (Old Case Id: 6469) and the same has been processed before Hon'ble Mr. Justice Vikram D Chauhan, Administrative Judge, Chitrakoot Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has firstly submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) vide online dated 14.12.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2019-2021 (2019-20 & 2020-21) of Sri Shushil Kumar Verma, A.D.J. (FTC), Chitrakoot, be laid before Hon'ble Mr. Justice Vikram D Chauhan, Administrative Judge, Chitrakoot Judgeship for His Lordship's kind perusal and orders?
