May kindly see the property statement received from Sri Sunil Kumar-I, Special Judge (SC/ST, Pev.of Atroci Act), Moradabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2012-14 (2012-13 & 2013-14) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2012-14 (2012-13 & 2013-14) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2012-14 (2012-13 & 2013-14), Total income from salary is Rs. 20,97,243/- and total deductions/savings//investment against GPF, GIS, Income Tax, PPF, & LIC and the balance of his savings bank account(s) is also enhanced by Rs.3,08,487/- in this financial years from previous year's balance, total of which is Rs.8,21,186/-. Thus, a sum of Rs.12,76,057/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that the officer has submitted his property statements of the financial years 2010-12 and the same has been processed online against Case Id: P00025982021 (Old Case Id: 4735) before Hon'ble Mr. Justice Rajeev Misra, Administrative Judge, Moradabad for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2012-14 (2012-13 & 2013-14) in its next financial year i.e., 2014-15 upto March 2015. The officer has firstly submitted his movable and immovable property statements for the financial years 2012-14 (2012-13 & 2013-14) through his offline letter dated 04.02.2017. As such, there is delay in submitting the same from the part of the officer, for which the officer has stated that "he could not submitted the property statements within time due to becoming seriously ill from heart attack and mid term transfer. He has apologised for the same and in future, he will will not repeat this mistake", as mentioned his letter dated 04.02.2017.

May, therefore, if approved, property statements for the financial years 2012-14 (2012-13 & 2013-14) of Sri Sunil Kumar-I, Special Judge (SC/ST, Pev.of Atroci Act), Moradabad be laid before Hon'ble Mr. Justice Rajeev Misra, Administrative Judge, Moradabad Judgeship for His Lordship's kind perusal and orders?
