May kindly see the property statement received online from Sri Abdul Quaiyum, Addl. District & Sessions Judge, Bareilly, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2014-2016 (2014-15 & 2015-16) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2014-2016 (2014-15 & 2015-16) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2014-2016 (2014-15 & 2015-16), the Gross income is Rs.29,60,167/- (Rs.25,92,691/- from Salary, Rs.3,49,476/- from Interest on Bank Account and Rs.18,000/- from Honorarium Lok Adalat) and total deductions/savings/investment against GIS, GPF, PPF, Insurances, Unit Plus II and Income Tax is Rs.10,59,839/- and the balance of his savings bank account(s) is also increased by Rs.11,88,185/- in this financial year from previous year's balance, total of which is Rs.22,48,024/-. Thus, a sum of Rs.7,12,143/- was therefore available with him to meet out the household expenditure of his family consisting two members of the financial year 2014-2016 (2014-15 & 2015-16).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2012-13 & 2013-14 offline and the same has been seen by Hon'ble Mr. Justice Abhinava Upadhyaya, the then Administrative Judge, Aligarh Judgeship, in the misc. file of the officer and His Lordship's pleased to order as under:

"In future promptness must be shown in declaration."

Accordingly, the order was communicated to officer concerned vide Court's letter no. 12681/IV-2902/ Admin A, dated 23.09.2015.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2014-2016 (2014-15 & 2015-16) in its next financial year i.e., 2016-17 upto March 2017. He has firstly submitted movable and immovable property statements of the financial year 2014-2016 (2014-15 & 2015-16) vide online dated 13.12.2021. As such, there is delay in submitting the same from the part of the officer, for which the officer has stated in his online reply dated 20.12.2023, that (in his verbatim) *"due to engagement in Judicial and Administrative work, it was slipped from my mind to submit the property statement in time. Kindly forgive me for the same."*

May, therefore, if approved, property statements for the financial year 2014-2016 (2014-15 & 2015-16) of Sri Abdul Quaiyum, Addl. District & Sessions Judge, Bareilly, be laid before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders?
