May kindly see the property statement received online from Sri Yashwant Kumar Saroj, A.D.J. (FTC), Lalitpur, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2016-2018 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2016-2018 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial year 2016-2018 (2016-17 & 2017-18)**, the Gross income from salary is Rs.20,69,820/- and total deductions/savings/investment against GIS, NPS, PPF, Insurances, Mutual Funds and Income Tax is Rs.10,17,070/- and the balance of his savings bank account(s) is also increased by Rs.7,90,008/- in this financial year from previous year's balance, total of which is Rs.18,07,078/-. Thus, a sum of Rs.2,62,742/- was therefore available with him to meet out the household expenditure of his family consisting three members of the financial year 2016-2018 (2016-17 & 2017-18) which seems meagre amount. In this regard, officer has stated in his online reply dated 13.01.2024, that *"my father who was retired Deputy commissioner income tax department and pensioner was living with me at that time and bears maximum of household expenditures at that time and also look after my small child aged 5 to 6 year. We have agricultural land and maximum wheats, cereals and mustered oils came from our own agricultural land. we are also simple living person and have no more expansive expenditures. About my father I have already made statement in my property statement financial year 2009-2010."*

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2014-2016 (2014-15 & 2015-16) online against Case Id : P00012782021 (Old Case Id : 3383) and the same has been processed before Hon'ble Mr. Justice Mayank Kumar Jain, Administrative Judge, Lalitpur Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2016-2018 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has firstly submitted movable and immovable property statements of the financial year 2016-2018 (2016-17 & 2017-18) vide online dated 18.12.2021. As such, there is delay in submitting the same from the part of officer, for which the officer has stated in his online reply dated 23.01.2024, that *"due to busy court work and unintentionally by mistake the statement could not filled up within that time."*

May, therefore, if approved, property statements for the financial year 2016-2018 (2016-17 & 2017-18) of Sri Yashwant Kumar Saroj, A.D.J. (FTC), Lalitpur, be laid before Hon'ble Mr. Justice Mayank Kumar Jain, Administrative Judge, Lalitpur Judgeship for His Lordship's kind perusal and orders?
