May kindly see the property statement online received from Sri Raghubar Singh, Additional District & Sessions Judge, Moradabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2019-21 (2019-20 & 2020-21), Gross income from salary Rs. 43,33,438/- and total deductions/savings/ investment against NPS, GIS, PPF, Income Tax, Repayment of Home loan, Mutual Funds and Insurance is Rs.22,20,205. Thus a sum of Rs. 21,13,233/- was therefore available with him to meet out the household expenditure of his family consisting of six members in the financial year 2019-21 (2019-20 & 2020-21) and the balance of his savings account is also decreased for Rs.7,60,242/- this financial year from previous year balance.

It is pertinent mention here that's Officer's father (Pensioner) having annual income Rs.3,96,000/-.

In this connection, it is submitted that the Officer has already submitted his property statement of the financial year 2018-19 offline in the Misc. file of the Officer and same has been processed before Hon'ble Mr. Justice Dinesh Kumar Singh, Administrative Judge, Moradabad for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial year 2019-21 (2019-20 & 2020-21) vide online dated 13.12.2021. As such, there is no delay in submission of property statement.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sri Raghubar Singh, Additional District & Sessions Judge, Moradabad be laid before Hon'ble Mr. Justice Dinesh Kumar Singh, Administrative Judge, Moradabad for His Lordship's kind perusal and orders?
