May kindly see the property statement online received from Sri Shahid Raza, Presiding Officer, Motor Accident Claims Tribunal, Kannauj regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2014-15 & 2015-16 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2014-15 & 2015-16 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2014-15 & 2015-16, Total income is Rs.28,30,734/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, GPF, Income Tax, PPF, Mutual Funds, Insurance policies and the balance of his savings bank account(s) is enhanced for Rs.2,53,702/- this financial year from previous year's balance, total of which is Rs.17,45,425/-. Thus, a sum of Rs.10,85,309/- was therefore available with him to meet out the household expenditure of his family consisting five members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2010-12 which had already been seen by Hon'ble Mr. Justice Devi Prasad Singh, the then Administrative Judge, Meerut, placed in the misc. file of the officer. And of the financial years 2012-14 are currently processed & separate note has made on eService ID no.P00043112021.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2014-15 & 2015-16 in its next financial year i.e., 2016-17 upto March 2017. He has submitted movable and immovable property statements of the financial years 2014-15 & 2015-16 vide online dated 18.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that *"very humbly submitted that due to some family disturbances and personal issues he could not submit his property statements from the year of 2010 onwards. He seeks unconditional apology and will take care in future. with regards"*, mentioned in remark column of movable proforma of 2012-14.

May, therefore, if approved, property statements of the financial years 2014-15 & 2015-16 of Sri Shahid Raza, Presiding Officer, Motor Accident Claims Tribunal, Kannauj be laid before Hon'ble Mr. Justice Ajai Kumar Srivastava-I, Administrative Judge, Kannauj Judgeship for His Lordship's kind perusal and orders?
