

## **Registrar(J)(Budget)**

May kindly see the property statement received online from Smt. Komal Shukla, Addl. Civil Judge (Sr.Div.)/ACJM., Mathura regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2018-2020 (2018-19 & 2019-20) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2018-2020 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

**In the financial year 2018-2020 (2018-19 & 2019-20)**, the Gross income is Rs.17,95,006/- and total deductions/repayment/savings/investment against GIS, NPS, PPF and Income Tax are Rs.3,69,092/- and the balance of her savings bank account is also increased by Rs.54,581/- in this financial year from previous year's balance, total of which is Rs.4,23,673/-. Thus, a sum of Rs.13,71,333/- was therefore available with her to meet out the household expenditure of her family consisting two members of the financial year 2018-2020 (2018-19 & 2019-20).

It is also pertinent to mention here that her husband is a Judicial Officer having monthly income of Rs.76,988/-, as mentioned by the officer.

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements held at the time of joining into U.P. Judicial Service offline and the same has been seen by Hon'ble Mr. Justice Shahihul Hasnain, the then Administrative Judge, Ramabai Nagar Judgeship, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2018-2020 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements of the financial year 2018-2020 (2018-19 & 2019-20) vide online dated 13.12.2021. As such, there is delay in submitting the same for which the officer has stated in the remark column, that (in her verbatim) *"I had submitted my property statement at the time of joining previously. The delay in furnishing the property statement was caused by the unprecedented devastation caused by the COVID-19 pandemic. The prevailing pandemic had created a continuous state of stress and anxiety in mind. I alongwith my family was also infected by the covid infection. I most humbly apologise for the delay in furnishing the property statement."*

May, therefore, if approved, property statements for the financial year 2018-2020 (2018-19 & 2019-20) of Smt. Komal Shukla, Addl. Civil Judge (Sr.Div.)/ACJM., Mathura, be laid before Hon'ble Mr. Justice Sanjay Kumar Singh, Administrative Judge, Mathura Judgeship for His Lordship's kind perusal and orders?
