

## **Registrar(J)(Budget)**

May kindly see the online property statements received from Sri Ajay Kumar Mishra, Additional Civil Judge (Sr. Div.)/A.C.J.M., Bulandshahar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Total Gross salary is Rs.19,08,476/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, PPF a/c and the balance of his savings bank account(s) enhanced for Rs.96,173/- this financial year from previous year's balance, total of which is Rs.3,55,188/-. Thus, a sum of Rs.15,53,288/- was therefore available with him to meet out the household expenditure of his family consisting two members for both the financial years 2018-19 & 2019-20.

In this connection it is submitted that he has submitted his property statement at the time of entering into Judicial Service which has already been seen by Hon'ble Mr. Justice Rajendra Kumar-IV, the then Administrative Judge, Ambedkar Nagar in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 firstly vide online dated 14.12.2021. As such, there is delay in submitting the same for which he has stated that *"he was unable to submit the property statement within stipulated time due to family liabilities and unintentional inadvertence. He most humbly apologise for the delay caused in submitting the property statement in time and request to kindly forgive his inadvertence"*, mentioned in remark column of movable proforma.

May, therefore, if approved, property statements for the financial year 2018-19 & 2019-20 of Sri Ajay Kumar Mishra, Additional Civil Judge (Sr. Div.)/A.C.J.M., Bulandshahar be laid before Hon'ble Mr. Justice Rajesh Singh Chauhan, Administrative Judge, Bulandshahr Judgeship for His Lordship's kind perusal and orders?
