May kindly see the property statement received online from Sri Nitin Kumar, Civil Judge (Senior Div.), Lakhimpur Kheri, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2015-17 (2015-16 & 2016-17) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2015-17 (2015-16 & 2016-17) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial year 2015-17 (2015-16 & 2016-17), the Gross income from salary is Rs.15,50,182/- and total deductions/savings/investment against GIS, PPF, Loan repayments, Insurences and Income Tax is Rs.4,45,892/- and the balance of his savings bank account(s) is also decreased by Rs.29,213/- in this financial year from previous year's balance. Thus, a sum of Rs.11,33,503/- was therefore available with him to meet out the household expenditure of his family consisting two members of the financial year 2015-17 (2015-16 & 2016-17).

It is also pertinent to mention here that the officer's wife is a Judicial Officer whose annual income is approx Rs.6,72,000/- for the financial year 2015-17 (2015-16 & 2016-17).

In this connection, it is submitted that the Officer has already submitted his property statement held at the time of joining into judicial service online against Case Id : P00015552021 (Old Case Id : 3669) and the same has been processed before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Lakhimpur Kheri Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2015-17 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto March 2018. He has submitted movable and immovable property statements of the financial year 2015-17 (2015-16 & 2016-17) vide online dated 14.12.2021. As such, there is delay in submitting the same for which the officer stated in the attachment dated 14.12.2021 that (in his verbatim) "It is humbly submitted that due to bonafide mistake and ill health, I could not send the aforesaid property statement on due time.I apologize for the same and I assure that in future I will send the statement timely."

May, therefore, if approved, property statements for the financial year 2015-17 (2015-16 & 2016-17) of Sri Nitin Kumar, Civil Judge (Senior Div.), Lakhimpur Kheri, be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Lakhimpur Kheri Judgeship for His Lordship's kind perusal and orders?
