May kindly see the online property statements received from Sri Gunandra Prakash, Additional District & Sessions Judge, Banda regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Total Gross income from salary are Rs.34,01,056/- and total deductions/ repayment/ savings/ investment against GIS, Income Tax, NPS, LIC policies, PPF a/c, Sukanya Samridhi Yojna and the balance of his savings bank account(s) is enhanced for Rs.7,10,852/- this financial year from previous year's balance, total of which is Rs.18,93,935/-. Thus, a sum of Rs.15,07,121/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

It is pertinent to mention here that his wife is Advocate having annual income of Rs.3,34,698/- and Rs.3,72,320/- in the financial years 2018-19 & 2019-20 respectively.

In this connection, it is submitted that officer has already submitted his property statement upto the financial year 2013-14, which has already been seen by Hon'ble Mr. Justice Akhtar Husain Khan, the then Administrative Judge, Hapur, placed in the misc. file of the officer. And property statements of the financial years 2014-15 & 2015-16 and 2016-17 & 2017-18, detailed office notes have been submitted on e-Service IDs 6505 and 6517 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 13.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that "due to serious illness of his mother her treatment is going on in AIIMS Delhi and SGPGIMS Lucknow and his father is also sick. Therefore there was disturbance in his family he could not submit this statement within time. He apologise for this delay and requested to accept his apology and forgive him", mentioned in remark column of movable proforma.

May, therefore, if approved, property statements for the financial year 2018-19 & 2019-20 of Sri Gunandra Prakash, Additional District & Sessions Judge, Banda be laid before Hon'ble Mr. Justice Shamim Ahmed, Administrative Judge, Banda Judgeship for His Lordship's kind perusal and orders?
