May kindly see the property statement online received from Dr. Dinesh Chandra Shukla, Presiding Officer, Special Court (MP/MLA), Prayagraj regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2019-21 (2019-20 & 2020-21), Total income is Rs.39,19,864/- (Gross income from salary is Rs.36,79,245/-, Bank Interest is Rs.23,951/-, FDR Income is Rs.16,420/-, Amount Received from United Insurance Company is Rs.71,000/- Amount Received from Mother's S/B A/c is Rs.1,29,248/-) and total deductions/ repayment/ savings/ investment against GIS, GPF, Income Tax, LIC Policy's, SIP, House Loan EMI, Car Loan EMI, Car Advance and the balance of his savings bank account(s) is enhanced by Rs.62,167/- this financial year from previous year's balance, total of which is Rs.24,80,985/-. Thus, a sum of Rs.14,38,879/- was available with him to meet out the household expenditure of his family consisting of three members in both of the financial years and the balance of his savings bank account(s) is decreased by Rs.93,386/- this financial year from previous year's balance

In this connection, it is submitted that the Officer has already submitted his property statements of the 2017-19 (2017-18 & 2018-19) online against case id-P00030542021 (Old Case Id : 5197) and same has been approved by the Hon'ble Dr. Justice Kaushal Jayendra Thaker, the then, Administrative Judge, Allahabad Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial years 2019-21 (2019-20 & 2020-21) vide online dated 13.12.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Dr. Dinesh Chandra Shukla, Presiding Officer, Special Court (MP/MLA), Prayagraj, be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Allahabad Judgeship for His Lordship's kind perusal and orders?
