May kindly see the property statement online received from Sri Vijay Kumar Vishwakarma, Additional District & Sessions Judge, Varanasi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2018-20 (2018-19 & 2019-20), his gross income from salary is Rs.29,17,820/- and total deductions/Savings/investments against NPS, GIS, Income Tax, NSC, FD, Insurances, SIP and Sukanya Samridhhi Yojna are Rs.14,53,284/-. The balance of Rs.1,422/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.14,65,958/- (Rs.14,64,536/- from salary and Rs.1,422/- from saving bank account withdrawal) was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2018-20 (2018-19 & 2019-20).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2014-15 to 2017-18 offline, which had already been seen by Hon'ble Ms. Justice Naheed Ara Moonis, the then Administrative Judge, Auraiya Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) vide online dated 13.12.2021. As such, there is delay in submitting the same. In this regard: officer has stated that due to excess work and lack of time that's the reason he could not send the property-statement for the financial years 2018-20 in time, he apologized for delay.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Vijay Kumar Vishwakarma, Additional District & Sessions Judge, Varanasi be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Varanasi Judgeship for His Lordship's kind perusal and orders?
