In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2013-15 (2013-14 & 2014-15) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2013-15 (2013-14 & 2014-15), Total income from salary Rs.11,59,061/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, CPF, Income Tax, Insurance policy, NSC, PPF and the balance of his savings bank account(s) is enhanced for Rs.28,333/- this financial year from previous year's balance, total of which is Rs.4,12,401/-. Thus, a sum of Rs.7,46,660/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both the financial years.

In this connection, it is submitted that the officer has submitted his property statement at the time of entering into judicial service, which has been processed before Hon'ble Mr. Justice Chandra Kumar Rai, Administrative Judge, Sonbhadra on eService ID no. 6389.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2013-15 (2013-14 & 2014-15) in its next financial year i.e., 2015-16 upto March 2016. He has submitted movable and immovable property statements of the financial years 2013-15 (2013-14 & 2014-15) firstly vide online dated 12.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has not given any reason for delay.
