May kindly see the property statement online received from Sri Chandra Mani Mishra, Special Judge (U.P. Dacoity.A.A.) Ramabai Nagar, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Gross income is Rs.42,92,048/- (income from salary including arrears & D.A. is Rs.40,19,521/- and income from bank interests is Rs.2,72,527/-) and total deductions/ repayment/ savings/ investment against NPS, PPF, GIS, PLI, LIC, Income Tax and the balance of his savings bank account(s) is also enhanced for Rs.19,17,306/- this financial year from previous year's balance are Rs.32,74,531/-. Thus, a sum of Rs.10,17,517/- was therefore available with him to meet out the household expenditure of his family consisting five members for both the financial years 2018-19 & 2019-20.

In this connection, it is submitted that officer has already submitted his property statement upto the financial year 2016-18, which has already been processed before Hon'ble Mr. Justice Subhash Vidyarthi, Administrative Judge, Ramabai Nagar on old case ID no.6559.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 14.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, he stated that he was suffering from cronic liver desease, hence due to underwent to living liver transplant (due to unavoiding circumstances) he could not submit his P.S. in time.

May, therefore, if approved, property statements for the financial years 2018-19 & 2019-20 of Sri Chandra Mani Mishra, Special Judge (U.P. Dacoity.A.A.) Ramabai Nagar be laid before Hon'ble Mr. Justice Subhash Vidyarthi, Administrative Judge, Ramabai Nagar Judgeship for His Lordship's kind perusal and orders?
