May kindly see the online reply dated 30.01.2024 received from Sri Mohan Kumar, Additional District & Sessions Judge (POCSO), Ambedkar Nagar at Akbarpur, in compliance of order of Hon'ble Mr. Justice Abdul Moin, the then Administrative Judge, Lakhimpur Kheri Judgeship in the matter of property statements for the financial years 2016-18(2016-17 & 2017-18), communicated to the officer.

In this connection, it is submitted that the officer had submitted his movable & immovable property statements for the financial years 2016-18(2016-17 & 2017-18) online dated 12.12.2021 on eServicesJO portal, which was put up before Hon'ble the Administrative Judge, Lakhimpur Kheri through detailed office note dated 29.11.2023, on which His Lordship has been pleased to pass the order dated 21.12.2023, which has been communicated to the officer on 21.12.2023.

In compliance of the aforesaid Hon'ble Court's order, Officer has submitted his online reply on 06.01.2024 forwarded by District Judge on 18.01.2024, which has been submitted before Hon'ble the Administrative Judge, Lakhimpur Kheri through detailed office note dated 22.01.2024, on which His Lordship has been pleased to pass the following order dated 25.01.2024:

"Perused the explanation of the officer concerned submitted online on 18.01.2024. The said explanation does not address any of the queries as have been raised by the undersigned on 21.12.2023. Considering the same, the officer is required to address the queries as indicated by the undersigned in the order dated 21.12.2023 within two weeks failing which the undersigned may proceed further with the matter."

The aforesaid Hon'ble Court's order has been communicated the officer online on 30.01.2024.

In compliance of the said Hon'ble Court's order, officer has submitted his online reply on 30.01.2024 forwarded by District Judge on 03.02.2024, in which he has stated (in his verbatim) that "It is a respectful request that there was a delay in resolving the objection in my property statement because my account number 160401000050312 in Indian Overseas Bank was temporarily closed due to lack of transactions for a long time, KYC was done again and after receiving the statement. Being uploaded. I apologize for the delay."

It is also submitted online property statements for the financial years 2014-15 & 2015-16 has been processed presently online and a separate office note has already been submitted for order on e-service ID no. 6564.

May therefore, if approved, movable & immovable property statement for the financial years 2016-18(2016-17 & 2017-18) along with the reply of Sri Mohan Kumar, Additional District & Sessions Judge (POCSO), Ambedkar Nagar at Akbarpur in compliance of His Lordship's order dated 25.01.2024 be laid before Hon'ble Mr. Justice Ajai Kumar Srivastava-I, Administrative Judge, Ambedkar Nagar at Akbarpur Judgeship for His Lordship's kind perusal and further orders?
