May kindly see the property statement submitted online received from Sri Dibyanand presently posted as Chief Judicial Magistrate, Amroha regarding submission of statements of movable and immovable properties acquired/held by him or any member of his family for the financial year 2015-17 (2015-16 & 2016-17) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2015-17 (2015-16 & 2016-17) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2015-17 (2015-16 & 2016-17), his Total income from salary and others sources is Rs. 19,62,510/- and total deductions/savings/investments against GIS, CPF, Income Tax, PPF, SBI Insurance, SIP and PLI is Rs. 11,36,209/- (including enhancement of Rs. 2,07,654/- in his S.B. A/cs against the balance of the previous year). Thus a sum of Rs. 8,26,301/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statements offline for the financial year 2014-15 which has already been seen by Hon'ble Mr. Justice Shamsher Bahadur Singh, then then Administrative Judge, Ballia Judgeship in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2015-17 (2015-16 & 2016-17) in its next financial year i.e. 2017-18 upto 31st March 2018. He has submitted movable and immovable property statements for the financial years 2015-17 (2015-16 & 2016-17) firstly vide his application dated 18.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that due to bonafide mistake and overload of work, the statement of property have not been sent by him in time and apologises and in future this will be strictly complied with.

May, therefore, if approved, property statements for the financial years 2015-17 (2015-16 & 2016-17) of Sri Dibyanand presently posted as Chief Judicial Magistrate, Amroha be laid before Hon'ble Mr. Justice Raj Beer Singh, Administrative Judge, Amroha Judgeship for His Lordship's kind perusal and orders?
