May kindly see the property statement online received from Sri Achal Pratap Singh, Civil Judge (Senior Division), Sonbhadra regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2019-21 (2019-20 & 2020-21), Total income Rs.32,45,702/- (income from salary Rs.30,66,874/- & income from agriculture Rs.1,78,828/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, CPF, Income Tax, Insurance policy, Sukanya Samridhi Yojna, PPF, SIP, repayment of home & car loan, total of which is Rs.20,76,700/-. Thus, a sum of Rs.11,69,002/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both the financial years. And the balance of his savings bank account(s) is reduced for Rs.6,10,036/- this financial year from previous year's balance.

It is pertinent to mention here that his wife Smt. Vineeta Singh is ACJM, Farrukhabad and her annual income for the F.Y. 2019-20 Rs.12,71,618/- and for the F.Y. 2020-21 Rs.16,31,136/-.

In this connection, it is submitted that the officer has submitted his property statement of the F.Y. 2017-19, which has been processed before Hon'ble Mr. Justice Chandra Kumar Rai, Administrative Judge, Sonbhadra on eService ID no. 6402.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial years 2019-21 (2019-20 & 2020-21) firstly vide online dated 12.12.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements of the financial years 2019-21 (2019-20 & 2020-21) of Sri Achal Pratap Singh, Civil Judge (Senior Division), Sonbhadra be laid before Hon'ble Mr. Justice Chandra Kumar Rai, Administrative Judge, Sonbhadra Judgeship for His Lordship's kind perusal and orders?
