In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2018-20 (2018-19 & 2019-20), his Total income from salary (Gross Salary) is Rs. 16,75,143/- and total deductions/savings/investments against NPS, GIS, Income Tax, L.I.C. and P.P.F. is Rs.3,70,926/-. Thus a sum of Rs.12,04,217/- was therefore available with him to meet out the household expenditure of his family consisting of two family members in both the financial years. And the balance of his savings bank accounts is decreased for 1,36,401/- this financial year from previous year's balance.

It is pertinent to mention here that his wife Smt. Mridula (Government Job) Cadre- Provencial Development Services (PDS), Post- Block Development Officer, Annual Income- Rs. 8,40,000/-

In this connection, it is submitted that the officer has already submitted his property statements at the time of joining, which was processed online on old case ID-3437 before Hon'ble Mr. Justice Sanjay Kumar Pachori, Administrative Judge, Pilibhit.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) vide his online application dated 13.12.2021. As such, there is delay in submitting the same from the part of the officer. For which he stated that the delay occurred due to new entrant in the service and inadvertence. The officer tenders unconditional apology for the delay.
