May kindly see the property statement submitted online received from Sri Dibyanand presently posted as Chief Judicial Magistrate, Amroha regarding submission of statements of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2017-19 (2017-18 & 2018-19), his Total income from salary and others sources is Rs. 33,14,228/- and total deductions/savings/investments against GIS, CPF, Income Tax, PPF, SBI Insurance, SIP and PLI is Rs. 14,13,006/- . Thus a sum of Rs. 19,01,222/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs. 1,58,642/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statements online for the financial years 2015-17 (2015-16 & 2016-17) which is also processed online and laid before Hon'ble Mr. Justice Raj Beer Singh, Administrative Judge, Amroha, Judgeship for kind perusal and order on e-service old Case Id no. 6573.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2017-19 (2017-18 & 2018-19) in its next financial year i.e. 2019-20 upto 31st March 2020. He has submitted movable and immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) firstly vide his application dated 18.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that due to bonafide mistake and overload of work, the statement of property have not been sent by him in time and apologises and in future this will be strictly complied with.

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Sri Dibyanand presently posted as Chief Judicial Magistrate, Amroha be laid before Hon'ble Mr. Justice Raj Beer Singh, Administrative Judge, Amroha Judgeship for His Lordship's kind perusal and orders?
