May kindly see the property statement submitted online received from Sri Ravindra Vikram Singh, District & Sessions Judge, Sonbhadra regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2009-11 (2009-10 & 2010-11) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2009-11 (2009-10 & 2010-11) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2009-11 (2009-10 & 2010-11), his Total income is Rs.19,67,227/- (income from salary including interest) and total deductions/savings/investments against GPF, GIS, IT, PPF approx, Insurances are Rs.12,31,838/- (including enhancement of Rs.5,91,383/- in his S.B. A/cs against the balance of the previous year). Thus a sum of Rs.7,35,389/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years.

It is pertinent to mention here that his wife Smt. Nalini Singh is a Teacher, monthly income Rs.24,000/-.

In this connection, it is submitted that the officer has already submitted his property statements upto the financial year 2008-09 which is also seen offline by Hon'ble Mr. Justice Shishir Kumar, the then Administrative Judge, Firozabad Judgeship in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2009-11 (2009-10 & 2010-11) in its next financial year i.e., 2011-12 upto March 2012. He has submitted movable and immovable property statements for the financial years 2009-11 (2009-10 & 2010-11) firstly vide his application dated 13.12.2021. As such, there is delay in submitting the same from the part of the officer and he has stated that due to transfer, look after the judicial work & administrative work of a district judge, very heavy work load as ADJ and missing some important documents, he could not get the sufficient time to collect the material for submission of property statement.

May, therefore, if approved, property statements for the financial years 2009-11 (2009-10 & 2010-11) of Sri Ravindra Vikram Singh, District & Sessions Judge, Sonbhadra, be laid before Hon'ble Mr. Justice Saurabh Srivastava, Administrative Judge, Sonbhadra for His Lordship's kind perusal and orders?
