May kindly see the property statement online received from Sri Sunil Kumar Tripathi, Chief Judicial Magistrate, Bulandshahar regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial years 2018-20 (2018-19 & 2019-20)**, his gross income from salary is Rs.27,19,791/- and total deductions/Savings/investments against, Deposits in Saving Bank Account, NPS, GIS, Income Tax, PPF, Repayment of Personal Loan, Home loan and advance, FD, RD and Insurances are Rs.15,57,200/-. The balance of Rs.1,94,815/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.11,62,591/- was therefore available with him to meet out the household expenditure of his family consisting three members in the financial years 2018-20 (2018-19 & 2019-20).

In this connection, it is submitted that the Officer has already submitted his property statement held at the time of Joining in to U.P. Judicial Service along-with for the financial years 2014-16 & 2016-18 offline, which had already been seen by Hon'ble Mr. Justice R.R. Awasthi, the then Administrative Judge, Sitapur Judgeship in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) vide online dated 13.12.2021. As such, there is some month delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Sunil Kumar Tripathi, Chief Judicial Magistrate, Bulandshahar be laid before Hon'ble Mr. Justice Rajesh Singh Chauhan, Administrative Judge, Bulandshahar Judgeship for His Lordship's kind perusal and orders?
