May kindly see the property statement received online from Sri Satish Kumar Tripathi, Addl. District & Sessions Judge, Rai Bareli, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2017-2019 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2017-2019 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2017-2019 (2017-18 & 2018-19), the Gross income from salary, Interest from S.B. account & others is Rs.26,14,459/- and total deductions/savings/investment against GIS, NPS, PPF, Insurances, Sukanya Samriddhi Account and Income Tax is Rs.7,35,782/- and the balance of his savings bank account(s) is also increased by Rs.1,59,605/- in this financial year from previous year's balance, total of which is Rs.8,95,387/-. Thus, a sum of Rs.17,19,072/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2017-2019 (2017-18 & 2018-19).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2015-2017 (2015-16 & 2016-17) offline and the same has been seen by Hon'ble Mr. Justice Ramesh Sinha, the then Administrative Judge, Agra Judgeship, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2017-2019 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial year 2017-2019 (2017-18 & 2018-19) vide online dated 13.12.2021. As such, there is delay in submitting aforesaid property statements from the part of the officer for which he has stated in the attachment namely "covering letter" dated 12.12.2021, that due to work load then transfer and promotion in the year 2019 and thereafter due to CORONA pandemic, was not able to submit the statement within the stipulated time for which he tenders his apologies and most respectfully begs for kind and sympathetic consideration.

District & Sessions Judge, Rai Bareli, be laid before Hon'ble Mr. Justice Arvind Singh Sangwan, Administrative Judge, Rae Bareli Judgeship for His Lordship's kind perusal and orders?
