May kindly see the property statements online received from Sri Rajeev Bharti, District & Sessions Judge, Mathura regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-20, total net income after usual deduction of Income tax for both the financial years are Rs.44,52,384/- and total deductions/ repayment/ savings/ investment (for both the financial years) against PPF a/cs, PLIs, loans, Insurance policies and the balance of his savings bank account(s) is enhanced for Rs.6,16,648/-, total of which is Rs.25,46,537/-. Thus, a sum of Rs.19,05,847/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

It is pertinent to mention here that annual earning of his wife received from FD and Customary Stridhan from her parents, brothers and father-in-law and rent of flat of Rs.2,73,040/- and Rs.3,87,820/- in the financial years 2018-19 & 2019-20 respectively.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2015-16 which had already been seen by Hon'ble Mr. Justice A.R.Masoodi, the then Administrative Judge, Deoria, placed in the misc. file of the officer in offline mode and property statements of 2016-18 has been processed separately on e-service ID no.6795.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-19 & 2019-20 vide online dated 13.12.2021. As such, there is delay in submitting the property statement from the part of the officer for which he has submitted that *due to his transfer in the Motor Accident Claims Tribunal & LAARA Court, there were shortage of proficient staff, So he was not able to submit it on time. In this regard the applicant apologizes unconditionally, with folded hands and assures that this type of repetition will never happen again in future, so It is humble request to present the annexed property statement of the applicant before the Hon'ble Court for kind consideration mention in remark column of movable proforma.*

May, therefore, if approved, property statements for the financial years 2018-19 & 2019-20 of Sri Rajeev Bharti, District & Sessions Judge, Mathura be laid before Hon'ble Mr. Justice Piyush Agrawal, Administrative Judge, Mathura Judgeship for His Lordship's kind perusal and orders?
