May kindly see the property statement received online from Sri Rajeev Kumar-II, Addl. District & Sessions Judge, Barabanki regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2018-2020 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2018-2020 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2018-2020 (2018-19 & 2019-20), the Gross income is Rs.35,84,371/- (Rs.34,65,675/from salary and Rs.1,18,698/- from Agricultural Income) and total deductions/savings/investment against GIS, GPF, PPF, LIC, Fund, House Loan repayments and Income Tax is Rs.17,76,784/- and the balance of his savings bank account(s) is also increased by Rs.33,128/- in this financial year from previous year's balance, total of which is Rs.18,09,912/-. Thus, a sum of Rs.17,74,459/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2018-2020 (2018-19 & 2019-20).

It is pertinent to mention here that his wife is a Govt. College Lecturer having annual income of approx. Rs.9,79,212/- & Rs.10,99,000/- for both financial year respectively.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2017-18 offline and the same has been seen by Hon'ble Mr. Justice Shashi Kant Gupta, the then Administrative Judge, Fatehpur Judgeship, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-2020 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has firstly submitted movable and immovable property statements of the financial year 2018-2020 (2018-19 & 2019-20) vide online dated 13.12.2021. As such, there is delay in submitting the same for which the officer stated in his online reply dated 14.01.2024, that "kindly receive my sincere apologies for being 9month late in the submission of the requirements I was not able to submit on date. Because of work load and family problems. I am sure that there will be no delay in the second chance. Again accept my apologies for delay caused."

May, therefore, if approved, property statements for the financial year 2018-2020 (2018-19 & 2019-20) of Sri Rajeev Kumar-II, Addl. District & Sessions Judge, Barabanki, be laid before Hon'ble Mr. Justice Vipin Chandra Dixit, Administrative Judge, Barabanki Judgeship for His Lordship's kind perusal and orders?
