May kindly see the property statement received online from Smt. Chhavi Kumari, Civil Judge (Senior Div.), Lakhimpur Kheri regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial year 2017-19 (2017-18 & 2018-19), the Gross income from salary is Rs.18,39,571/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, PPF, Loan repayments and Insurances are Rs.4,95,419/- and the balance of her savings bank account is also enhanced by Rs.7,002/- in this financial year from previous year's balance, total of which is Rs.5,02,421/-. Thus, a sum of Rs.13,37,150/- was therefore available with her to meet out the household expenditure of her family consisting two members of the financial year 2017-19 (2017-18 & 2018-19).

It is also pertinent to mention here that the Officer's husband is a Judicial Officer whose annual income is approx. Rs.10-11 lacs in the financial year 2017-19 (2017-18 & 2018-19).

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements held at the time of joining into judicial service online against Case Id : P00044952021 (old case id : 6651) and the same has been processed before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Lakhimpur Kheri Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. She has submitted movable and immovable property statements of the financial year 2017-19 (2017-18 & 2018-19) vide online dated 14.12.2021. As such, there is delay in submitting the same. In this regard, the officer has stated in attachment dated 14.12.2021 that (in her verbatim) ***"It is humbly submitted that due to bonafide mistake and ill health,I could not send the aforesaid property statement on due time.I apologize for the same and I assure that in future I will send the statement timely."***

May, therefore, if approved, property statements for the financial year 2017-19 (2017-18 & 2018-19) of Smt. Chhavi Kumari, Civil Judge (Senior Div.), Lakhimpur Kheri, be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Lakhimpur Kheri Judgeship for His Lordship's kind perusal and orders?
