May kindly see the property statement online received from Sri Arjun, Additional Civil Judge (Sr.Div.)/ACJM, Agra, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below :

In the financial years 2018-20 (2018-19 & 2019-20), Gross income from salary is Rs.20,55,842/- and total deductions/repayment/ savings/ investment against NPS, GIS, Income Tax, PPF, Mutual Fund is Rs.7,96,839/-. Thus, a sum of Rs.12,59,003/- was therefore available with him to meet out the household expenditure of his family consisting two members for both the financial years. And the balance of his savings bank account(s) is also decreased by Rs.48,811/- in this financial year from previous year's balance.

It is pertinent to mention here that the wife of the officer Smt. Sarita dhama, salaried forensic science lab Delhi government (Designation-Senior Scientific assistant) Gross Pay-10 lakh per annum.

In this connection, it is submitted that the Officer has already submitted his property statements upto the financial year 2016-18 which has already been processed before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Agra on old case ID no.-6106.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) vide online dated 13.12.2021. As such, there is delay in submitting the same, for which he has stated that delay occurred due to covid-19 pandemic he could not submit the property statement on time.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Arjun, Additional Civil Judge (Sr.Div.)/ACJM, Agra, be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Agra for His Lordship's kind perusal and orders?
