May kindly see the property statement online received from Smt. Sudha Singh, Civil Judge (Senior Div.), Unnao regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

(1) In the financial years 2019-21 (2019-20 & 2020-21), Gross income from salary is Rs.29,63,480/- and total deductions/savings/ investment against NPS, GIS, Income Tax, PPF, Mutual Funds, Insurances and the balance of her savings bank account(s) is also enhanced by Rs.1,93,773/- in this financial year from previous year's balance, total of which is Rs.13,10,938/-. Thus, a sum of Rs.16,52,542/- was therefore available with her to meet out the household expenditure of her family consisting of four members in the both of the financial.

It is pertinent mention here that Officer husband (Assistant District Prosecution Officers) having annual income Rs.9,00,000/-..

In this connection, it is submitted that the Officer has already submitted her property statement for the financial year 2017-19(2017-18 & 2018-19) online against case id- P00020962021 (Old case id-4223) and same has been processed before Hon'ble Mr. Justice Karunesh Singh Pawar, Administrative Judge, Unnao for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has submitted movable and immovable property statements of the financial year 2019-21 (2019-20 & 2020-21) vide online dated 12.12.2021. As such, there is no delay in submission of property statement.
