May kindly see the property statement received online from Sri Mangal Dev Singh, Civil Judge (Senior Div.), Jalesar-Etah, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2013-2015 (2013-14 & 2014-15) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2013-2015 (2013-14 & 2014-15) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2013-2015 (2013-14 & 2014-15), the Gross income from salary is Rs.13,92,154/- and total deductions/savings/investment against GIS, NPS, PPF and Income Tax is Rs.4,20,642/- and the balance of his savings bank account(s) is also increased by Rs.76,438/- in this financial year from previous year's balance, total of which is Rs.4,97,080/-. Thus, a sum of Rs.8,95,074/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2013-2015 (2013-14 & 2014-15).

In this connection, it is submitted that the Officer has already submitted his property statement at the time of joining into U.P. Judicial Service online against Case Id : P00045732021 (Old Case Id : 6730) and the same has been processed before Hon'ble Mr. Justice Nalin Kumar Srivastava, Administrative Judge, Etah Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2013-2015 (2013-14 & 2014-15) in its next financial year i.e., 2015-16 upto March 2016. He has submitted movable and immovable property statements of the financial year 2013-2015 (2013-14 & 2014-15) vide online dated 14.12.2021. As such, there is delay in submitting aforesaid property statements from the part of the officer. In this regard, the officer has stated in his letter as attachment dated 14.12.2021, that due to workload and lack of information, he could not send the property statement within the prescribed time limit, for which he seeks forgiveness for delay and assures that in future, property statements will be sent within the prescribed time limit.

May, therefore, if approved, property statements for the financial year 2013-2015 (2013-14 & 2014-15) of Sri Mangal Dev Singh, Civil Judge (Senior Div.), Jalesar-Etah, be laid before Hon'ble Mr. Justice Nalin Kumar Srivastava, Administrative Judge, Etah Judgeship for His Lordship's kind perusal and orders?
