May kindly see the property statement online received from Sri. Rakesh Kumar Singh-II, Additional District & Sessions Judge, Meerut regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-20 (2018-19 & 2019-20), Total Income is Rs.4274188/- (Gross income from salary is Rs.26,39,168/- and LIC Matured for Rs.1,50,000/-) and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax, PPF, LIC Policy, SBI Life Insurance and the balance of his savings bank account(s) is enhanced by Rs.78386/- this financial year from previous year's balance, total of which is Rs.18,15,016/-. Thus, a sum of Rs.24,59,172/- was available with him to meet out the household expenditure of his family consisting of four members in both of the financial years.

In this connection, it is submitted that the Officer has already submitted his property statements of the 2016-18 online against case id-P00046002021 and same has been moved before the Hon'ble Mr. Justice Justice Saumitra Dayal Singh, Administrative Judge, Meerut Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) vide online dated 14.12.2021. As such, there is delay in submitting the same. In this regard officer has stated that Due to family problems and Covid -19 pandemic he was not able to collect all the relevant documents relating to his property statements and same were not submitted on time. he apologized for same and assured that this will not be repeated again in future.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri. Rakesh Kumar Singh-II, Additional District & Sessions Judge, Meerut be laid before Hon'ble Mr. Justice Saumitra Dayal Singh, Administrative Judge, Meerut for His Lordship's kind perusal and orders?
