Thus, a sum of Rs.12,40,682/- was therefore available with him to meet out the household expenditure of his family consisting of three member in both of the financial year.

He has submitted movable and immovable property statements of the financial year 2018-20 (2018-19 & 2019-20) vide online dated 14.12.2021. As such, there is delay in submitting the same. In this regard, officer has most humbly tenders an unconditional apology for delay in submitting the property statement in due time and undertakes that such delay will not occur in future.
