May kindly see the property statement online received from Sri Jaihind Kumar Singh, Chief Judicial Magistrate, Hathras regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2015-17 (2015-16 & 2016-17) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2015-17 (2015-16 & 2016-17) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2015-17 (2015-16 & 2016-17), Gross income from salary is Rs.18,48,090/- and total deductions/savings/ investment against NPS, GIS, PPF, Income Tax, Repayment of loan, Insurances and the balance of his savings bank account(s) is also enhanced by Rs.1,15,426/- in this financial year from previous year's balance, total of which is Rs.12,02,303/-. Thus a sum of Rs.6,45,787/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial years 2015-17 (2015-16 & 2016-17).

It is pertinent mention here that's Officer's wife (Private Teaching) annual income was Rs.1,80,000/- for the financial years 2015-16 and 2016-17.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2013-15 (2013-14 & 2014-15) online against P00046262021 (old case id-6783) and same has been processed before Hon'ble Mr. Justice Ashutosh Srivastava, Administrative Judge, Hathras for His Lordship's kind perusal and orders .

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2015-17 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto March 2018. He has submitted movable and immovable property statements of the financial years 2015-17 (2015-16 & 2016-17) vide online dated 14.12.2021. As such, there is delay in submitting the same. In this regard, officer stated that he sincerely apologize for delay in filling the property statement in time and delay on his part is due to inadvertence and due to overwork. In future he shall submit property statement in time and he never repeat this mistake again.
