May kindly see the property statement received online from Sushri Ankita Singh-II, Civil Judge (Senior Div.), Sultanpur regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

In the financial year 2018-20 (2018-19 & 2019-20), the Gross income from salary is Rs.15,72,850/- and total deductions/ repayment/ savings/ investment against GIS, CPF, GVR, Income Tax and Insurances are Rs.2,81,715/- and the balance of her savings bank account is also enhanced by Rs.6,16,695/- in this financial year from previous year's balance, total of which is Rs.8,98,410/-. Thus, a sum of Rs.6,74,440/- was therefore available with her to meet out the household expenditure of her family consisting three members of the financial year 2018-20 (2018-19 & 2019-20).

It is also pertinent to mention here that the Officer's father and mother are pensioner whose annual pension is approx. Rs.6.5 lakhs & Rs. 3.5 lakhs respectively in the financial year 2018-19 and approx. Rs.7 lakhs & Rs. 4.5 lakhs respectively in the financial year 2019-20.

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements at the time of joining online against Case Id : P00041162021 (old case id : 6266) and the same has been processed before Hon'ble Mr. Justice Irshad Ali, Administrative Judge, Sultanpur Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements of the financial year 2018-20 (2018-19 & 2019-20) vide online dated 18.12.2021. As such, there is delay in submitting the same. In this regard, the officer has stated that (in her verbatim) "the delay in submitting the property statement occurred due to covid-19, because the data or the details needed to fill the statement could not be collected on time. I am extremely sorry for the delay. I shall submit the property statement on time in future."

May, therefore, if approved, property statements for the financial year 2018-20 (2018-19 & 2019-20) of Sushri Ankita Singh-II, Civil Judge (Senior Div.), Sultanpur, be laid before Hon'ble Mr. Justice Irshad Ali, Administrative Judge, Sultanpur Judgeship for His Lordship's kind perusal and orders?
